1. Purpose. To **publish** instructions for the activation of a Composite Interrogation-Translator Team.

2. General. The subject unit will activate on 29 September in compliance with the **instructions** contained in reference (a) and (b).

3. Information. The primary mission of this team will be to provide **interrogation-translator** support to **Fleet** Marine Force, Atlantic units in the **accomplishment** of their assigned missions.

a. The Composite **Interrogation-Translator** Team will function under the Assistant Chief of Staff, G-2 who will prepare training schedules and prepare the team for the accomplishment of its primary mission.

b. **Billeting** for enlisted personnel. of the Composite **Interrogation-Translator** Team will be provided **by the Headquarters Commandant.**

c. Headquarters, **Force Troops** will maintain **communications and crypto** guard for the 2d Composite Interrogation-Translator Team.

d. **In determining** suitability for assignment of members to the **Composite Interrogation-Translator** Team provisions of Marine Corps Order 1200.4A will be complied with.

e. Linguists **will** be assigned to the Composite **Interrogation-Translator** Team by Force **Troops** Special Order.

4. Action. On 29 September the Commanding Officer, Headquarters Company, Force Troops, **Fleet Marine** Force, Atlantic will take action as indicated **below.**






